### **Previous Meeting Minutes**

MSA to approve IWMSC Board of Managers meeting minutes from December 7, 2008.

### **Treasurer's Report**

Virgil reported there are \$6,152 in Checking and \$2,564 in Savings/CD accounts.

### **Registrar's Report**

Paige confirmed that all the HMS teams re-registered for 2009 (WSU and Moses Lake had not as of previous meeting.)

Paige estimated 187 members in the Inland NW LMSC. Actual number as of 2/8/09 is 194. HMS: 167, LCNM: 19, UNAT: 8

### **Nominations Process – Shirley Schreiber**

The following people have been nominated for each officer position:

Chair – Paige Buehler

Vice-chair – no candidates

Secretary – Kristin Heath (WVM) & Matt Bronson (FAFB)

Treasurer – Virgil Crampton (WSU, incumbent) & Allen Kirpes (WVM)

Bylaws state that no more than two candidates from one team can run for officer positions. Discussion followed about whether the BoM might need to suspend that rule or if there was a time limit on it (i.e. through the nominations period until Feb. 1). Result of the discussion is that Matt Bronson will change his nomination from secretary to vice-chair. Wes Bratton will beat the TCAS bushes for any candidates for secretary or vice-chair.

## **Insurance coverage**

Level of urgency to have individual swimmers register with USMS is dependent on whether club/team needs USMS coverage. For example, WSU Masters is a team of swimmers who are part of the WSU university recreation swim club which is covered through WSU for insurance purposes. However, it limits its enrollment to the WSU population. Central Washington University operates much the same way. A portion of its swimmers register with USMS to take advantage of our meet opportunities.

Moscow Chinooks Masters practices at the University of Idaho swim center, but is not affiliated with the university. It rents the pool time and needs insurance coverage

through USMS by having all of its swimmers registered with USMS. It is open to all participants including the university community.

For workout groups or clubs that need the USMS insurance coverage they need to have a process in place that ensures all their swimmers are registered with USMS and covers "trial" swimmers who want to try out the Masters swim program for a given period of time before signing up with the group and registering with USMS.

The recommended way to do this, as described at the insurance workshop at the USMS convention

- Have USMS/IWMS registration forms available on deck
- New swimmers fill out and sign before participating
- Write "TRIAL" on the form and keep the form with the team equipment/papers
- When the swimmer is ready to pay the USMS/IWMS fee, pair the form with the check to send to the registrar
- Or have the swimmer confirm that they registered on-line and then shred the form.

If you keep paperwork at the pool, please respect people's privacy of information and use a locked box. MCM uses a small file box with a hole through which a luggage lock can be used to secure the contents. It's not high-security, but at least it indicates that if someone is found breaking into the box, there is a problem.
